1. When directed on or about 12 May 1957, in compliance with reference (a) and (b), you will take charge of the personnel listed on enclosure (1) and proceed to the U. S. Naval Station, Bermuda, B.W.I., for temporary additional duty for a period of about 18 days in connection with Marine Corps ceremonial commitments.

2. Your itinerary will be approximately as follows:

a. 1030, 12 May: Depart Marine Barracks for USNAS Anacostia, D. C. to arrive thereat not later than 1045.

b. 1230, 12 May: Depart USNAS, Anacostia, D.C. for Kindley Air Force Base, Bermuda, B.W.I., arriving thereat at approximately 1700.

c. On or about 29 May 1957: Depart Kindley Air Force Base, Bermuda, B.W.I., for USNAS, Anacostia, D. C. and further, Marine Barracks, Washington 3, D.C.

3. Upon arrival at the U. S. Naval Station, Bermuda, B.W.I., you will report to the Commanding Officer, Bermuda Tattoo Detachment for duty as Executive Officer and further deliver the personnel under your charge for such duty as may be directed by the Commanding Officer, Bermuda Tattoo Detachment.

4. Government Air Transportation is available and directed in the execution of these Group Travel Orders.

5. The expense to the Government incurred by these orders is in the public service.

6. Upon completion of this temporary additional duty on or about 29 May 1957, you with the personnel under your charge will return to this command and resume your regular duties.

7. Appropriation data as contained in reference (a) for these orders is: APFN 171106.11 MOTRP-57, OC 022/OPF/023/ENL/, EXACCT 43912, BUCONT NR 58601 and BUCONT AGTY NR 27. The approximate total cost of these orders is estimated to be \$1971.00.
